1. Balloting will be used to determine the order of priority and the balloting will be performed by computer. Only individuals or company purchaser(s) which is/are incorporated in Hong Kong are permitted to participate in the balloting procedures.

以抽籤方式決定選擇住宅物業的次序，抽籤將以電腦操作。只有個人或於香港註冊成立的公司可以參與抽籤程序。

2. The following restrictions apply to the First Day of Sale and thereafter:-

(a) Specified residential properties are offered for sale to individuals or company purchaser(s) which is/are incorporated in Hong Kong only. For avoidance of doubt, no specified residential properties shall be offered for sale to company purchaser(s) which is/are not incorporated in Hong Kong.

(b) A purchaser shall only be allowed to purchase not more than one (1) residential property in the Development (whether or not the residential properties purchased are included in this Sales Arrangement). Purchasers comprising different combination of individual(s) are regarded as the same purchaser.

(c) Company purchaser(s) shall not be entitled to purchase any of the specified residential properties listed in Price List No. 1A.
